NOTES ON THE HARVARD LIBRARIES

PERSONNEL COMMITTEE

A study of professional library personnel in the Harvard University Library is now under way; as tentatively outlined, its scope will include definition of the professional librarian and his qualifications, the place of professional librarians in the academic community, professional development, organization and staff structure, review and grievance procedures, communication and participation in policy-making, intern programs, salaries, working conditions and benefits, and the function and structure of a staff organization.

While the undertaking is not a response to *demands* by anyone, there have been comparable investigations during recent months at other major university libraries and, with many segments of Harvard now engaged in self-examination, this seems an appropriate time for Harvard librarians to take stock of their situation. In April the chief administrative officers of the Library appointed a Preliminary Committee of seven, with Ronald L. Weiher of Baker Library as Chairman, to consider the scope of the proposed study, specify major areas to be investigated, and recommend procedures for selecting and organizing a Study Committee on Professional Library Personnel.

This group nominated thirty-five persons — five in each of seven categories, to insure representation of the College Library, large faculty libraries, smaller libraries, younger staff members, senior members of the staff, technical-service personnel, and public-service personnel — and all members of the University Library staff holding Corporation appointments were invited to participate in the election, which was held at the end of May.

As a result of the balloting, members of the Study Committee are Kenneth E. Carpenter, Curator of the Kress Library in the Baker Library, Graduate School of Business Administration; Mrs. Lenore M. Dickinson, Head Cataloguer of the Andover-Harvard Theological Library; Mrs. Anne W. Gilliland, Administrative Assistant for Reference and Circulation in the Harvard College Library; Sharon Hamby, Administrative Assistant for Lamont Library; Mrs. Ruth E. Hill, Librarian of the Museum of Comparative Zoology; Mrs. Susan K. Martin, Systems Librarian in the Harvard College Library; and Edwin E. Williams, Associate University Librarian.

TEACHING ASSIGNMENTS

Two members of the staff were on leave during a portion of the summer in order to join library-school faculties. *Antonio Rodríguez-Buckingham* of the Peabody Museum Library was Visiting Professor at the State University of New York, Albany, where he gave a course on bibliography with particular attention to the use of computer techniques for bibliographical purposes. *Robert R. Walsh*, Administrative Assistant in the University Library, went to the University of Illinois, Champaign-Urbana, to conduct a graduate seminar on planning library buildings.

His most recent book, *Proverbs, Sentences, and Proverbial Phrases, from English Writings Mainly Before 1500*, was published by the Harvard University Press in 1968.
