Card Catalogs of the Harvard University Fine Arts Library 1895-1981. 516 microfiche. New York: K. G. Saur, Inc., 1984. (Includes Dictionary Catalog, Catalog of Auction Sales Catalogs, Catalog of the Rübél Asiatic Research Collection, and Shelf List Catalog.)

Catalog of the Arabic Collection, Harvard University. 6 vols. Boston: G. K. Hall & Co., 1983. (Lists holdings of the Middle Eastern Department of the College Library and Arabic works in the Andover-Harvard, Countway, Houghton, and Law School libraries. Comprises over 90,000 entries in three sections: main listing, in dictionary arrangement, by author, title, and subject; alphabetical listing of specialized subject headings; and alphabetical listing of serial holdings. Edited by Fawzi Abdulrazak, Arabic Language Specialist in the College Library, with introductory essay by David H. Partington, Assistant Librarian for Middle Eastern Collections.)

"Catalogers and Computers Create Milestone Interlibrary Record," *Library of Congress Information Bulletin*, 43:19 (7 May 1984), 150-151. (Reports first instance of Harvard University Library changing Library of Congress in-process cataloging record to fully cataloged record, online.)

Chadbourn, Erika S., with Lynne Hollyer and Richard McNally, compilers. *William Henry Hastie: An Inventory of His Papers in the Harvard Law School Library*. 133 p. Cambridge: Manuscript Division, Harvard Law School Library, 1984. (Lists contents of 110 manuscript boxes containing opinions, other court-

related papers, and other writings and correspondence, and 23 cartons of Judge Hastie's briefs. Mrs. Chadbourn is Curator of Manuscripts and Archives in the Law School Library.)

Clack, Mary E., and Sally F. Williams. "Using Locally and Nationally Produced Periodical Price Indexes in Budget Preparation," *Library Resources & Technical Services*, 27:4 (October-December 1983), 345-356. (Serial Records Librarian and Budget and Planning Officer in the College Library discuss Widener Library periodicals price index and its usefulness for budget preparation.)

(Provides alphabetical list of authors and list of contents of each reel of microfilm collection. This temporary guide will be superseded by one with more detailed bibliographic citations.)

Guide to the Card Catalogs of the Harvard University Fine Arts Library 1895-1981. 96 p. New York: K. G. Saur, 1984. (Guide to microfiche edition of catalog, prepared by staff of Library.)

The Harvard Library: A National Treasure. 7 p. [Cambridge: Harvard University Development Office, 1984]. (This illustrated brochure emphasizes the importance of donations to the continued excellence of the Library.)

Harvard Theatre Collection. *Shakespeare's First Globe Playhouse: The Harvard Theatre Collection Model.* 20 color slides. Cambridge 1984. (Slides provide interior and exterior views and details of reconstruction by C. Walter Hodges. Accompanied by 34-page, illustrated booklet.)

Harvard University Library. *Distributable Union Catalog.* Seventh cumulation, 292 microfiche, Cambridge, August 1984. Distributed commercially by K. G. Saur, Inc., New York. (Microfiche catalog recumulated and reissued every six months.)

———. *Endowed Book Funds at Harvard University.* 12 p. [Cambridge, 1984]. (Published to assist in the effort to find new book funds, this pamphlet discusses the importance of such funds and reproduces representative bookplates from various libraries.)

———. *Energy Policy.* 2,387 entries. *International Relations.* 1,347 entries. Cambridge, 1984. (Bibliographies created from Distributable Union Catalog records, sorted by Library of Congress subject headings. Monthly supplements to initial bibliographies list additions to University Library collections.)

———. *Photographs at Harvard and Radcliffe: A Directory.* 83 p. Cambridge, 1984. (Lists fifty repositories of photographs and provides brief descriptions of the collections, as well as indexes to the names, places, and topics mentioned in the descriptions. Illustrated by photographs from the collections. Information collected and compiled by Harvard Photo Curators Group, introduction by Karen R. Lewis.)

(Documents the activities of the Women in the Community Project, funded by the National Endowment for the Humanities and administered by the Schlesinger Library.)
